Justin D'Agostino MH is the global CEO of world-leading international law firm Herbert Smith Freehills, overseeing its client, people, practices, and growth strategies.


Based in Hong Kong, he works closely with the firm's largest clients, both in his personal practice role and as a regional and global business leader, and leads the firm's 6,000 talented people.

A Duke University graduate, Sears serves on various nonprofit boards, including the Williams Institute of UCLA, the Palette Fund, the Global Equality Fund of the U.S. Department of State, Lambda Legal Defense & Education Fund, The North Carolina Community Foundation and the National Advisory Council of the Stonewall National Archives & Museum.
