Shemara Wikramanayake Managing Director and CEO, Macquarie Group

Shemara has been Macquarie Group's Managing Director and CEO since late 2018. Macquarie is a global financial group providing clients with asset management, banking, leasing, advisory and risk and capital solutions. Headquartered and listed in Australia, Macquarie operates in 31 markets and has over \$A560 billion in assets under management. Shemara joined Macquarie in 1987 in Macquarie Capital in Sydney. In her time at Macquarie, Shemara has worked in six countries and across several business lines, establishing and leading Macquarie's corporateadvisory offices in New Zealand, Hong Kong and Malaysia, and the infrastructure funds management business in the US and Canada. Shemara has also served as Chair of the Macquarie Group Foundation.

As Head of Macquarie Asset Management for 10 years before her appointment as CEO, Shemara led a team of 1,600 staff in 24 markets. Macquarie Asset Management grew to become a world-leading manager of infrastructure and real assets and a top 50 global public securities manager.

In 2018, Shemara was appointed a Commissioner of the Global Commission on Adaptation, a World Bank-led initiative which seeks to accelerate climate adaptation and create concrete solutions which enhance resilience. In 2019 Shemara was appointed by the UN's Special Envoy for Climate Action, MichaelBloomberg, to the Climate Finance Leadership Initiative which seeks a six-fold increase in climate mitigationinvestment from the private sector. Before joining Macquarie, Shemara worked as a corporate lawyer at Blake DawsonWaldron in Sydney. She holds Bachelor of Commerce and Bachelor of Laws degrees from UNSW and completed the Advanced Management Program at Harvard Business School in 1996.



Todd Sears Founder and CEO, Out Leadership

Todd Sears is the founder and CEO of Out Leadership, the first company in history whose sole product is LGBTQ+ equality. Out Leadership connects leaders across the world's most influential industries to foster business growth, cultivate talent, and drive equality forward, and currently counts 98 of the world's most powerful companies as its members.

Sears has spent over 20 years working at the intersection of finance and equality. He began his career as an investment banker before joining Merrill Lynch as a financial advisor. There, he created the first team of financial advisors in Wall Street focused on the LGBTQ+ community and brought almost \$2 billion of new assets to the firm from LGBTQ+ couples and nonprofit organizations. Subsequently, expanding his leadership in Diversity, Todd pioneered award-winning diversity initiatives as Head of Diversity and Inclusion. Sears started Out Leadership in 2010.

A Duke University graduate, Sears serves on various nonprofit boards, including the Williams Institute of UCLA, the Palette Fund, the Global Equality Fund of the U.S. Department of State, Lambda Legal Defense & Education Fund, The North Carolina Community Foundation and the National Advisory Council of the Stonewall National Archives & Museum. Additionally, he is the founding chair of Jeffrey Fashion Cares, which raised over \$8mm for LGBTQ+/HIV causes over the decade he led it.

Originally from Tarboro, North Carolina, Sears is driven by his confidence that businesses have the power to advance LGBTQ+ equality and generate a high return on equality. He currently lives in New York City.

While completing a Master in Business Administration, Kate lectured at University of Melbourne and was a director of Midsumma Festival for just over three years. From there, her career pivoted into corporate leadership and she held a NSW Government position as project direct or for its Future Transport project. This was followed by roles as Partner for Aurecon (NSW and Victoria) and then Head of Change and Communications, Better Risk Outcomes Program with Commonwealth Bank.

Kate was co-chair of the SGLMG board before stepping down to head up Sydney WorldPride. Her devotion to the LGBTIQ community is equalled only by the value she brings to it. Kate has been volunteering for LGBTIQ+ organisations for over 20 years. An outstanding leader, creative thinker, tireless worker, and compassionate human being.



Dawn Emsen-Hough Director, ACON's Pride Inclusion Programs

Dawn Hough is the Director of ACON's Pride Inclusion Programs (Pride in Diversity, Pride in Sport, Pride in Health + Wellbeing). All programs provide employer support for all aspects of Lesbian, Gay, Bisexual, Transgender and Intersex (LGBTI) inclusion either within the workplace, Australian Sport or through health and wellbeing service provision.

Dawn started within ACON in 2009 specifically to develop and establish the national Pride in Diversity Program and to develop the Australian Workplace Equality Index (national benchmark on LGBTI workplace inclusion). Since that time, the program has grown substantially and gained an international reputation for its leading practice and gold standard index. Dawn has authored five workplace publications on aspects of LGBTI workplace inclusion and with her team, extended the Pride in Diversity Program to Sports incorporating a Pride in Sport Program and world first national sports index and a program targeting LGBTI inclusive service provision - Pride in Health & Wellbeing.

Dawn sets the strategic direction for all divisional programs, continues to author LGBTI inclusivity publications in addition to authoring and managing all programmatic indices in order to measure and shift leading practice in LGBTI inclusivity annually.

Dawn was appointed Adjunct Senior Fellow, University of Queensland,

She currently sits on the Risk Management & amp; Planning committee of Sydney World Pride.

Tara McKenty is the Creative Head at Google APAC, where she and her team's remit is to come up with creative uses of Google's products and platforms for Asia Pacific's largest clients. From creating children's books that test the eyesight of children, to an MS Society 'numbing soap' that brings home the effects of the condition (TED 'Ads Worth Spreading'), to creating real-time marketing platforms that reunite lost dogs with their owners, Tara continues to disrupt the status quo and as a consequence has won over a hundred international awards during her advertising rebellion.



Anna Brown CEO, Equality Australia

Anna Brown OAM (she/her) is a lawyer, advocate and founding CEO of Equality Australia, a national organisation dedicated to equality for LGBTIQ+ people built from the successful YES campaign. Her fingerprints are on nearly every major reform for LGBTIQ+ people in recent years including playing a crucial role in achieving marriage equality [as Co-Chair of the 'YES' campaign and running the challenge against the postal survey in the High Court.

Anna has been instrumental in hard fought battles to secure federal LGBTIQ+ discrimination protections, improve access to birth certificates for trans people, outlaw conversion practices and right historical wrongs by establishing schemes to erase historical homosexual offences. Anna's legal work has also helped to reduce barriers for young trans people accessing vital hormone treatment and furthered legal recognition of sex and gender diversity.]

She was previously Legal Director at Human Rights Law Centre, an advisor to the former Attorney-General and Deputy Premier of Victoria Rob Hulls, a senior associate at law firm Allens Linklaters and Federal Court associate. She was named one of Australia's top 10 influential women by the Australian Financial Review in 2019 and inaugural Victorian GLBTI person of the year in 2014.
